93.3 THE BULL'S "KENNY CHESNEY" CONTEST OFFICIAL RULES

The Station will conduct the **93.3 THE BULL'S "KENNY CHESNEY" CONTEST** (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

All entries may be played on the air. <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished. Station's decisions as to the administration and operation of the Contest.
