93.3 THE BULL'S "MATTS BRAIN BUSTER" CONTEST OFFICIAL RULES

Starting with caller #1 the station will take calls until the correct answer is given. Once the correct answer is received that caller will be deemed the winner and notified on that call. <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
