93.3 THE BULL'S "MATTS BRAIN BUSTER " CONTEST OFFICIAL RULES

The Station will conduct the **93.3 THE BULL'S "BRAIN BUSTER" CONTEST** (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Contest Period. The Contest entry period will begin on at or around 12:10pm MT on November 4, 2024 and will run through November 8, 2024 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

3. **How to Enter.**

On-Air: Listen to the Station weekdays during the Contest Period. When the Station ask the "Brain Buster" trivia question listeners must call the Station at 801-570-9393. Starting with caller #1 the station will take calls until the correct answer is given. Once the correct answer is received that caller will be deemed the winner and notified on that call. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

4. **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST.
